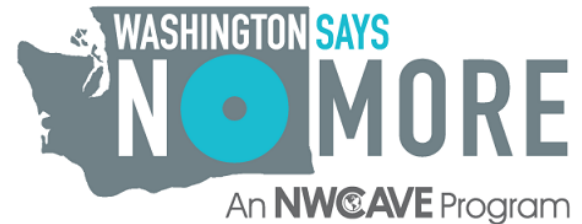

Known to many in Southern California as the founder of the Foothill Arthritis Connection, Michelle is an award-winning media consultant and publicist with over 25 years experience in non-profit management, media communications, and human & civil rights advocacy.

Michelle holds a communication's degree and has applied her education and expertise to helping businesses and organizations obtain visibility through the media, community relations, and the Internet.

Michelle also helps families of missing children keep their child's face and case visible through national media outlets including "America's Most Wanted" with John Walsh on Lifetime, HLN's Nancy Grace Show, "Issues" with Jane Velez-Mitchell on HLN, Fox News, CNN's Larry King Live, and People Magazine to name a few.

Michelle has served on the National Center for Missing and Exploited Children Advisory Board for Take 25, a Court Appointed Special Advocate (CASA) for Clark County, WA and is co-founder of Northwest Coalition Against Trafficking (NWCAT) which on June 14, 2012 became an arm to the new non-profit the National Women's Coalition Against Violence & Exploitation which she serves as President and Co-Founder and she was elected this year to the FBI Citizens Academy Alumni Association.

Michelle is producer of a full-length documentary "Your American Teen" (*which won the Columbia Gorge International Film Festival 'Best Feature Documentary'*) is a member of Society of Professional Journalists, Arthritis Foundation, Human Rights Campaign and Alliance for Women In Media.

Michelle was diagnosed at seventeen with Juvenile Rheumatoid Arthritis and throughout the years has been diagnosed with Fibromyalgia, Osteoarthritis and Cervical pre-cancer which resulted in many surgeries; she turned lemons into lemonade by speaking out and advocating for the causes and people closest to her heart and ultimately helping herself in the process. Michelle has been a presenter and keynote speaker throughout the country on topics related to rheumatic diseases, human trafficking, child safety and LGBTQ issues. Michelle is a regular child advocate contributor for television, cable and radio including CNN, KXRW, iHeart Radio, HLN, CBS, ABC and NBC networks.

In her spare time Michelle is host of "Voices for Justice" on Blog Talk Radio, enjoys spending time with her two beautiful nieces and is always working on transitioning to becoming a vegan again. She is also the proud mother of two rescued dogs.

Summit Co-Chair Biography – Katie Yates



Katie Yates was born and raised in Portland, Oregon. Yates has been involved in community and volunteer work since she was a young girl and grew to have a passion for non-profit organizations.

She left Oregon after graduating from Rex Putnam High School in 2014 to attend Washington State University in Pullman, Washington. There she became a member of the sorority chapter Alpha Omicron Pi. With her passion being sexual assault awareness and prevention, she served two years at WSU Pullman as Risk Manager for her sorority chapter to which she organized and attended programs that promoted safety awareness, sexual assault prevention, and social event safety management.

After her Sophomore year she officially moved to Vancouver, Washington and transferred to WSU-Vancouver, where she completed her last two years of college. Since August 2017, Yates has been working on Washington Says No More and her impressive work landed her a marketing internship with NWCave later that year. In December of 2017, her team- "Ignite Agency"- won first place for the Washington Says No More program proposal. The following semester Yates lead her class on implementing Washington Says No More.

She graduated from Washington State University Vancouver in May, 2018 with her B.A. in Integrated Strategic Communications of Edward R. Murrow College of Communications with her minor in Women Studies. She now serves as the Program Director for NWCave's Washington Says No More.



OPENING SESSION SPEAKERS

Clark County Councilwoman Temple Lentz Mayor of Vancouver City Council, Anne McEnerny-Ogle



Temple Lentz was elected to the county council in November 2018 and took office Jan. 2, 2019 for Clark County Council District 1. In November 2014, Clark County voters passed a home rule charter establishing the council/manager form of government. Councilor Lentz served as secretary of the elected Board of Freeholders, which drafted the charter that was approved by the voters. She recently served as Chair of the Clark County Commission on Aging, and previously served on the Clark County Parks Advisory Board, Vancouver Parks and Recreation Advisory Commission and Vancouver Charter Review Committee.

With a background in nonprofit management and private sector marketing and communications, Councilor Lentz also created and hosts a live, local talk show and has served on the boards of many local nonprofits.

She graduated with honors from The University of Chicago where she earned a bachelor's degree in English language and literature. Councilor Lentz is a 2009 graduate of Leadership Clark County, was a recipient of the Vancouver Business Journal's Accomplished & Under 40, was the first Impactful Woman of the Year for Clark County in 2017, and received the 2017 Iris Award for Women's Leadership.



In November 2017, **Anne McEnerny-Ogle** was elected to a four-year term as Mayor. Anne served on City Council from January 2014 through December 2017. She was also Vancouver's Mayor Pro Tem from January 2016 through December 2017.

Anne earned a Bachelor's Degree in Education from Southern Oregon State College in 1974 and a Master's Degree in Education from Lewis and Clark College in 1976. Anne retired after teaching 30 years in Lake Oswego Public Schools and serving as the chair of the mathematics department. During this time, she was a consultant to numerous school districts in Washington and Oregon, presented her work at state and national mathematics conferences, and served as editor and author for Oregon's State Math journal. She was a college and university lecturer and continues to supervise student teachers.

Dr. Kathie Mathis is a Doctor of Psychology, a Nationally Certified Psychologist, a Diplomate of the Psychotherapy Association and international trainer and speaker. She is certified in drug/alcohol abuse, domestic violence abuse, batterers facilitation, anger management, Sociopathic -type relationships, emotional addiction, parenting, high conflict relationships, court visitation monitoring, laughter therapy, and so much more that she states she can wall paper a house with all the certificates.



During her career, Kathie has developed and introduced national models in mentoring, abuse prevention, and school-based stop bullying programs. She also authored books, written monthly columns for magazines and newspapers. She is recognized as a leader in anger management and is a trainer and supervisor in anger management for the National Association of Anger Management Association and California Association of Anger Management Providers; domestic violence prevention and intervention certification trainer for therapists, psychologists, social workers, law enforcement, parole and probation departments/individuals and counselors as well as clergy and corporations and anyone desiring. She also helped co-create a popular training entitled “The SociopathicStyle Relationship Facilitator Training,” that is being presented nationally.

Dr. Mathis has also created a program on laughter and happiness therapy for medical environments/staff dealing with illness, for military, seniors, and others having difficulty with life’s hardships, PTSD and depression and other negative emotions. It is called “The Hilarious Healing Project” (www.hilarioushealping.com).

She is asked to be a keynote speaker at conventions and conferences. She also is a specialist in the sociopathic-type relationship and child abuse. Dr. Mathis actively participates in helping find missing and human traffic victims and has worked on high profile cases. Dr. Mathis is the National Training Director for National Women’s Coalition Against Violence and Exploitation (NWCAGE). Kathie also works on and testifies in, high profile and severely abusive family court cases where children are being sexually molested and victimized by a parent. She is an emotional addiction specialist and also helped set the standards for California’s Drug and Alcohol programs.

Dr. Mathis has received the following awards: Woman of the Year 2005; Woman of Distinction Award; Woman of the Year - Zonta International; Who’s Who; SCV Newsmaker Award; Professional Woman’s Who’s Who; Omni Award; Making a Difference for Women; Congressional Order of Merit, along with recognition awards from Los Angeles County Supervisors, Domestic Violence Council, President Bush, Congress and Senate acknowledgments. Kathie was just chosen “Woman of the Year 2009/2010” by the National Professional Women’s Association.

Film Screening Keynote Speaker Prosecutor Kym Worthy

Wayne County Prosecutor **Kym L. Worthy** received her undergraduate degree in economics and political science from the University of Michigan, and her law degree from the University of Notre Dame School of Law. In 1984, she began her legal career at the Wayne County Prosecutor's Office and, in 1989 she became the first African-American selected by the office as a Special Assignment Prosecutor. She specialized in high profile murder cases, including the prosecution of Toni Cato Riggs (convicted of the murder of her husband, a returning Gulf War Veteran) and of two Detroit Police Officers convicted in the beating death of motorist Malice Green.

On January 6, 2004, Ms. Worthy came full circle in her career and returned to the Wayne County Prosecutor's Office, this time as the Wayne County Prosecutor, the first African American and the first female to hold the position. She had declared her candidacy for the office for the November 2004 election. These plans were accelerated when the incumbent resigned and she was appointed by a solid majority of the Wayne County Judges.

She has been widely acknowledged for her courage and integrity in charging a case that could have negatively impacted her political career. As a result of this case, Ms. Worthy has received the following awards and honors: 2009 Michigan Chronicle Women of Excellence Award; 2009 Southfield-Lathrup Optimist Club Public Servant of the Year; 2008 Detroit Free Press Renaissance Hero; 2008 Radio One Newsmaker of the Year; 2008 Channel 7 Spotlight on the News Newsmaker of the Year; 2008 Spirit of Detroit Award; 2008 Crain's Most Powerful Attorneys; 2008 MADD Outstanding Service Award; 2008 CLEO Legacy Public Service Award, and 2008 Crain's Women to Watch and featured in Essence Magazine in February 2010.

Ms. Worthy is nationally known for her tremendous efforts when over 11,000 untested sexual assault kits were found in a Detroit Police Department Warehouse in 2009. In January 2015, Enough SAID was launched as an independent collaboration for justice between Michigan Women's Foundation, the Wayne County Prosecutor's Office and the Detroit Crime Commission. The mission of Enough SAID is to raise funds to finish testing the remaining kits, investigate the resulting cases and prosecute rapists. Ms. Worthy has been relentless in her quest to have each kit tested because recognizes that each sexual assault kit has the potential to bring justice to sexual assault victims, to solve multiple crimes, as well as the potential to exonerate a person who was wrongfully convicted

Tina Orwall has represented the 33rd legislative district since 2009. Supporting sexual assault victims/rape kit reform, reducing truancy, the Foreclosure Fairness Act, student loan debt protections, suicide prevention, anti-trafficking, compensation for those wrongly convicted, and adoptee rights are among her legislative accomplishments. Tina has worked with all levels of government to help embrace best practices to better serve the community. Her 20 years of experience working in the public mental health system, as well as her expertise in strategic planning in workforce development and affordable housing have established her as a valued legislator and community leader. She earned both a BS in Psychology and a MSW in Administration from the University of Washington.



Melissa Schwartz is the Chief Operating Officer at The Bromwich Group. As a consultant to the Joyful Heart Foundation, she has led advocacy-focused media strategy and public relations since 2012.

Melissa has two decades of strategic and crisis communications experience in government, the private sector, and at nonprofit organizations.

Melissa was tapped by the Obama administration to manage crisis communications for the federal agency responsible for the regulation and oversight of offshore drilling in U.S. federal waters following the 2010 Deepwater Horizon oil spill.

Also among her career highlights is: her work managing Joyful Heart's multi-year Executive and Legislative Branch-focused advocacy campaign to federally fund efforts to clear the nationwide rape kit backlog; serving as a communications strategist for the national "NO MORE" PSA series on domestic violence and sexual assault; and working as a senior spokesperson at the U.S. Departments of Justice and the Interior, and for U.S. Senator Barbara A. Mikulski

Melissa is an Adjunct Professor who currently teaches for the University of Washington's Communication Leadership graduate program, and has previously provided instruction at Johns Hopkins University's Master of Arts in Communication program and the University of California, Washington Center. She has published chapters in PR News Guidebooks focused on PR Measurement, Crisis Management, Media Training, and Corporate Social Responsibility, and is a contributor to the Huffington Post. She earned her M.A. in Political Communications from Johns Hopkins University and graduated summa cum laude from the University of California, Berkeley with a B.A. in American Studies and a minor in Dramatic Arts.

In Phoenix, Carmen worked in a Fortune 500 financial institution where her skills of customer service, risk management & underwriting, & financial analysis reporting developed.

In 2013, Carmen relocated to Vancouver with her husband & had to start fresh in a new community with a differing demographics & community culture. Carmen's past professional experience in corporate business & entrepreneurship provided the opportunity to transition into her current passion in community health prevention education & advocacy. In 2018, Carmen rolled out the first Spanish speaking class in Vancouver WA that focuses on healthy living lifestyle including diabetes prevention in partnership with Washington State University Vancouver. 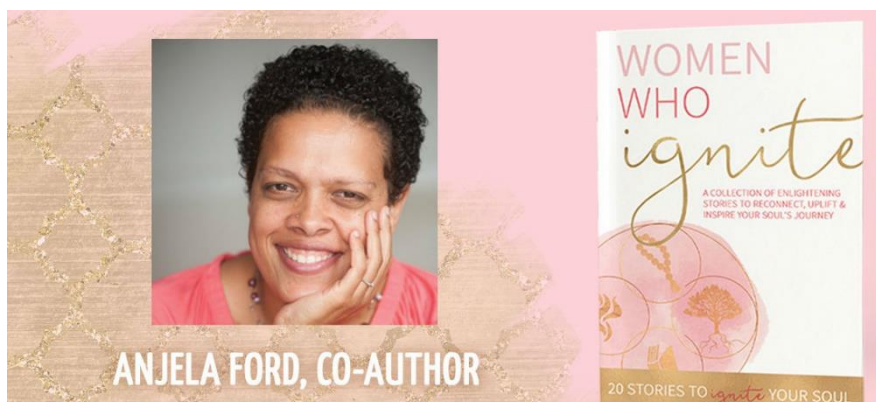

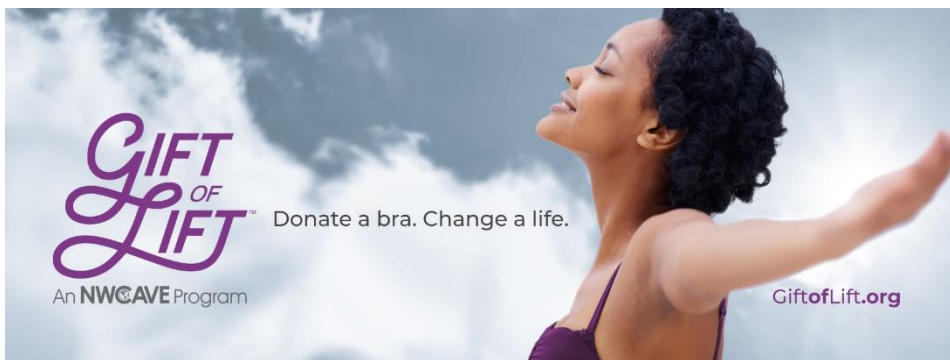
Speaker's Biographies – Meet NWCAVE

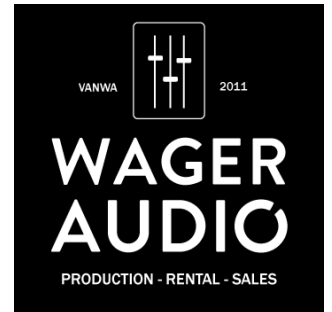
